- 1. The Board reviewed, and approved as written, the minutes of the April 30, 2019 meeting of the Board of Directors of Berkowners Inc.

- 3. Wavecrest reported that after three rounds of interviews we have not filled the assistant super position.
- 4. Wavecrest was directed to get further information on lobby cameras.
- 5. Pia reported work will begin in two weeks on super/assistant super's apartment renovations.
- 6. Admissions Committee Report: Prospective buyers were approved for the following apartments: Apt. A-46 in 77th Street for \$525K and Apt. B-53 in 35th Avenue for \$450K
- 7. Fitness Center Update Capital Improvements Committee Testing only found asbestos remanants in outside one of the old bathroom areas which could be sealed off if necessary from the area in which we are proposing to locate the fitness center. The next step is to get a quote on removal and containment in place and compare that to the cost of sealing off he space. Eric will discuss with Jay this week.
- 8. Window Update Capital Improvements Committee We received 5 responses to the RPF. We have interviewed one architect to date (Rand) with CTA to follow this Thursday. Goal is to narrow the field of architects to 3 and then have those 3 interviewed by the Board


9. Garden Pathway Update – Capital Improvements Committee – The work has been postponed until October.





FLIP TAX SURVEY ANALYSIS


The Flip Tax Survey was closed on June 1, 2019. We only received 89 responses from the 270 apartments owned by shareholders. The results follow.















In order to implement a Flip Tax, which requires an amendment to our By-Laws and Proprietary Lease, we need to get 2/3 of the outstanding shares to vote in favor of it. According to the data collected, we still need to get 43,225 shares to be in favor of a Flip Tax in order for it to pass.



Currently, only 25% of the outstanding shares are in favor of some form of Flip Tax. In order for this to pass, 66.7% of the outstanding shares need to be in favor of the Flip Tax.

Because the data we collected does not bring us anywhere near the number of shares we need to implement the Flip Tax, the Board has decided to table this discussion at the present time. This does not mean we will not reconsider implementing a Flip Tax in the future.
